

ROSS COUNTY BOARD OF DEVELOPMENTAL DISABILITIES

Meeting Minutes

November 13, 2025

CALL TO ORDER: Baylee Butler called the meeting to order at 6:00PM.

ROLL CALL: Board Members in attendance were Hunter Robinson, William Showman, Randi Uhrig, Baylee Butler. and Katie Guba. Dan Riddle and Amy Beam were excused.

NEW BUSINESS:

- A. Life Exploration Program – Emily Ewing** – Emily provided an overview of the Life Exploration Program for Pioneer School graduates with a slide show:
- The program gives students opportunities for hands-on job and life skills training in the community (e.g., maintenance at Ross County Parks, bath bomb production at Maggie's Aromatics, customer service at Café ChilliCoffee.
 - Students rotate through various local businesses, supported by therapists and job coaches, and work on skills tailored to specific job requirements.
 - Community response has been overwhelmingly positive with more businesses reaching out to participate
 - This program has led to noticeable improvements in students' engagement and independence.
- B. Dr. Fish – Sibling of the Year Award – Kara Brown** –
- Kara showed her award she received for being the recipient of Dr. Tom Fish Sibling of the Year Award for being recognized for her work as a SIB Shop Facilitator.
 - SIB Shops provide support for siblings of children with disabilities, fostering community, understanding, and peer relationships.
 - Activities include games, discussions, crafts, and guest speakers (therapists) tailored by age groups.
 - The program has grown from 4-30 participants, offering a place for siblings to connect and share experiences.
- C. Announcement** – Ross County has the Special Olympics Statewide Athlete of the Year, Noah Hiles.

B. Landrum Youth Empowerment Center Updated – Jared Halm, Business Manager provided an update on the bid process; Approval received from OMAS which was TAT Realty, LLC.; Working with engineering group to draft contract and schedule the work.
